- Winterized Dickenson Bathrooms, Dining Hall, Housekeeping Area of Dickenson 1
- Extracted water from Heritage Center basement, and repaired broken pipe in Heritage Center

Dec 16, 2019

- Wire wheeled and sanded burners and flame sensor on office furnace.
- Started rough in of drain waste and vent plumbing in Kimberling Hall, shower installed, started installation of insulation in ceiling sloping sections, started installation of insulation in exterior upstairs rooms and below staircase and duct work started.

Jan 20, 2020

- Trayer's Water Wells replaced pressure switch and pressure gauge on grove well.
- Repaired burst pipe and flooding in Dickinson 2 and eliminated leaking valve in director's residence due to high pressure on well.
- Measured mattresses in cabins to order waterproof / bed bug proof mattress covers.
- Insulated sloping sections of second floor rooms in Kimberling Hall, started insulation of 2nd floor
 exterior walls. Installed insulation under stairs and created insulated roof hatch for Kimberling Hall,

- Replaced missing shingles on Blue Spruce.
- Finished 2nd floor electrical rough in Kimberling Hall, roughed in kitchen electrical outlets, roughed in first floor lighting and installed majority of 2nd floor drywall, roughed in conference room electrical outlets

May 18, 2020

- Opened winterized buildings
- Treated Campground and Dining Hall wells.
- Created list of things to think about for sanitizing for Covid-19
- Attended multiple webinars including Christian Camp Leaders webinar regarding Covid-19, Michigan Camps webinar 4/29/20
- Spent numerous hours researching ACACAMP Guidelines

Jun 15, 2020

- Replaced batteries and replaced connectors on Blue Spruce fire alarm
- Transferred 1000s of gallons of water from lower campground to new property.
- Rough in electrical started wiring panel and furnace installation started in Kimberling Hall

July 20, 2020

- Dealt with broken overhead power line to Pioneer Cottage.
- Kimberling Hall finished electrical rough in, finished installing remaining drywall on the ceiling and walls, taped all seams on drywall, sanded the joints, and started applying a second coat of joint compound.
- Filled in holes at the waterfront caused by erosion from the lake. Seawall in the swimming area is starting to collapse.

Aug 17, 2020

- Worked on dealing with mold issues in Lodges
- Cleaned, repacked, and tightened wheel bearings on landscape trailer.
- Helped plan steps on renovation process on Hare Cottage, worked on siding, installed drywall, and applied joint compound
- Worked on applying joint compound and installed corner bead in Kimberling Hall

Sept 21, 2020

- Removed 3 trees (SE corner of Dining Hall, SW corner of Canteen Pavilion, and tree inside retaining wall behind Kimberling Hall.)
- Added 20 yards of road gravel to drive to lodge.
- Borrowed tractor and dump trailer from Tony Russell
 - o Removed split rail fence near Canteen Pavilion for tree service.
 - o Moved firewood from newly cut trees out back
 - Filled in holes along the Dining Hall trench.
 - Removed overgrown shrubs around Rush Cottage.
 - Moved fallen tree in Wilderness Area to cut at a later date, pulled down hanging tree in wilderness area, cut and moved tree and dead pine tree near Blue Spruce to be split later.
- Assessed rot damage to Camp Store and worked on a game plan for lifting building up to preserve the structure. Raised Camp Store 6 in and graded valley between Tabernacle and Camp Store to minimize washout under Camp Store and prepared Store for paint.
- Replaced regulator rectifier, fixed connection for regulator on Exmark Zero turn.
- Hare Cottage Installed remaining windows and French door, bent coil stock for door jamb, installed starter strip, J channel, brick molding, siding and various trims, helped install vinyl plank flooring, installed frost free hydrant, installed new deck boards, and added new guard rail post.
- Worked on applying joint compound and started finish sanding some areas in Kimberling Hall
- Trayer's Water Wells chlorinated lodge well, flushed sediment and chlorine, performed 2 water tests 24 hours apart. Performed additional routine water sample 9-9-20,9-10-20, and 9-11-20

This will not come as a surprise to anyone, but the past year has been an odd one for this food service manager. Not having normal camp this summer was such a strange experience. In this report I usually talk about all of the food donations we received, the great kitchen staff and volunteers we have, the incredible support of our partner churches.... but not this year. But I also learned to appreciate the opportunities we are sometimes given to slow down. I genuinely hope to never have another summer like this last one. I hope we never have to make the hard decision to close our programs. But I'm grateful for the experience - for the reminder to slow down and trust God even when things look like they are falling apart.

Family Campground Committee's Report

The Family Campground committee met on Feb. 8, 2020, at the RLCA Welcome Center.

The Family Campground Handbook was reviewed and a few changes were made. The most significant change is that at the end of the summer camping season those moving their campers for the winter but wanting to reserve their lot for next year's camping season are asked to make a \$50 deposit to save the lot. The deposit will be applied to the following year's fee.

The committee then discussed a lot of ideas for the campground. It was mentioned that campground members used to do things together socially, and we would like to do more of that. Cathy and Wynell agreed to work on some events. Everyone agreed that the campground is one of the first things people see when they visit RLCA, and the members want to give a good first impression. It was agreed that there should be a spring and fall cleanup, and that could be part of a social event. It was decided to set a date for a spring cleanup when we can help each other clean up the campground. Luke, as the Facility Manager, will take care of removing any trash. Once the work is done, then those in the campground would share in a pot luck. Every one left the meeting excited and looking forward to a great summer.

The Family Campground is usually open on May 1st, but due to the Covid pandemic, it was not opened until the first weekend of June. In addition, due to high water levels, twelve of the campsites in the lower campground could not be used. The flooding was a problem all summer for some of the camp sites.

The first social event was held on Fourth of July weekend. The pavilion was decorated and people could play different games or have their pictures taken in front of a back drop. There was also an excellent pot luck. The members hope that this will be the first of many of this type of social event.

In July there was a new challenge for the campground. With many of the campsites out of service due to the high water, there were not enough camp sites to meet the need. It became obvious that there needed to be a clarification of the wording regarding the transfer and subleasing of lots. The individual campsites are what the usage agreements are for, and not for the campers that are on the sites. There is often a waiting list for available sites. When the campground rules are reviewed for next summer it will be made clear that if someone sells a camper, the camper will have to be moved. The person who signed the agreement for the camp site may move another camper on the site, or cancel the agreement. The camp site cannot be subleased to the one who bought the camper or anyone else. The next person on the waiting list will have the option of getting the vacated lot. If there is no one on the waiting list for a camp site, the person who purchased the camper will have the option of signing an agreement for the camp site.

It is uncertain if the flooding in the lower campground will be an ongoing problem. The trustees will determine if something will be done to prevent this from happening again. Some options are being considered.

This summer a Face Book group was made for the campground members. We hope that this will help share information and news for everyone involved in the camp ground.

There is a total of 58 sites in the campground. 35 were rented for entire 2020 camping season. 31 sites paid for winter storage. Due to the high water 12 of the camp sites could not be used resulting in some units having to be moved.

The members of the Family Campground anticipate that next summer will be more normal and that there will be the usual activities, and that some of plans made for 2020 can be carried out in the summer of 2021.

This year was quite different due to Covid - there was more time for projects due to camp not running this summer however there were fewer work days this year due to restrictions of Covid.

This year, flooding caused lots of issues. The lake level was about 30" above normal. The water rose above the campfire pit at Vesper Point and water was under the handicap ramp. The highwater caused the seawall to start collapsing and this will need to be replaced at a cost of approximately \$25,000. The water was also very high in the Family Campground; the water level was high enough to close 12 sites for the majority of the season.

Lots of progress has been made on Kimberling Hall - siding, windows, electrical roughed in, plumbing roughed in, insulation, the majority of HVAC has been completed, drywall has been hung, seams have been taped and joint compound is in the finishing stages at this time.

We met with Building God's Way architects via a Zoom conference call on April 27th to discuss the building process for future building and what role they would have if they were to be involved in the project.

Hare cottage was renovated to become housing for the Office Manager. Renovations included updated electrical, installed washer and dryer hookup, insulated, drywall, flooring, windows, siding and relocated furnace to give room for additional insulation.

On September 21st the Property Development Committee met to discuss the use of Rush Cottage. It was decided to convert the cottage into storage for lawn equipment. Building will be updated with new siding, update electrical, remove extra windows, install windows and garage doors.
